FIRST AID

DIRECTIONS FOR USE

Intended for postharvest control of Penicillium digitatum (green mold), Penicillium italicum (blue mold), Phytophthora spp. (brown rot) on citrus fruits.

PacRite KPhos is formulated for aqueous application only as a dip, wash, or drench. Used as directed, PacRite KPhos has curative and preventative action and should be integrated into an overall disease management program within each packinghouse. PacRite KPhos is compatible with TBZ and imazalil fungicides. Prior to tank mixing PacRite KPhos with other agricultural chemicals, conduct a jar test as follows: Add the proportionate amounts of the products to 1 qt. of water or wax/oil emulsion. Add wettable powders and water-dispersible granules first, followed by liquid flowables, and emulsifiable concentrates last. After thorough mixing, let stand for at least 5 minutes. Separation, globules, sludge, flakes or other precipitates are indicative of physical incompatibility. Physical compatibility is indicated if the combination remains mixed or can be remixed readily.

THE CROP SAFETY OF ALL POTENTIAL PESTICIDE TANK MIXES INCLUDING ANTI-SCALD AGENTS AND WAXES HAS NOT BEEN TESTED ON ALL CITRUS VARIETIES. BEFORE APPLYING ANY TANK MIX, CONFIRM SAFETY TO THE TARGET FRUIT.

DOSE RECOMMENDATIONS:

In dips, wash tanks, and drenchers, apply PacRite KPhos at rates of 1.2-3.5 gal. of product per 100 gal. of water. Use higher rate under severe disease pressure. Ensure thorough coverage of treated fruit. Treatment solution may be heated up to 50° C (122° F) for better effectiveness. Periodically check the treatment solution to insure the proper concentration of the active ingredient. Once treated, allow fruit to air dry. Repeated applications of PacRite KPhos may be necessary.

Tip container on its side and roll it back and forth, ensuring at least one complete revolution, for 30 seconds. Stand the container on its end and tip it back and forth several times. Turn the container over onto its other end and tip it back and forth several times. Empty the rinsate into application equipment or a mix tank or store rinsate for later use or disposal. Repeat this procedure two more times. Offer for recycling or reconditioning, or puncture and dispose of in a sanitary landfill, or by incineration, or, if allowed by state and local authorities, by burning. If burned, stay out of smoke.
