FIRST AID

Citrus: Postharvest control of blue, gray, green molds and stem-end rot. This product is concentrated and should be diluted one (1) gallon SOPP Soap with nine (9) gallons of water to make a 2% sodium ortho-phenylphenate tetrahydrate treating solution. Apply as a spray, flood or dip with contact period of 30 to 60 seconds. Flush fruit with fresh water after treatment.

Tolerance - 10 ppm from postharvest application expressed as o-phenylphenol.

STORAGE & DISPOSAL

Do not contaminate water, food, or feed by storage and disposal.

PESTICIDE STORAGE: Store this product in a cool, dry area away from direct sunlight and heat to avoid deterioration. In case of spill, flood areas with large quantities

PESTICIDE DISPOSAL: Product or rinsates that cannot be used should be diluted with water before disposal in a sanitary sewer.

CONTAINER DISPOSAL: Nonrefillable container. Do not reuse or refill this container. Clean container promptly after emptying. Triple rinse as follows: Empty the remaining contents into application equipment or a mix tank. Fill the container $\frac{1}{4}$ full with water. Replace and tighten closures. Tip container on its side and roll it back and forth, ensuring at least one complete revolution, for 30 seconds. Stand the container on its end and tip it back and forth several times. Turn the container over onto its other end and tip it back and forth several times. Empty the rinsate into application equipment or a mix tank or store rinsate for later use or disposal. Repeat this procedure two more times. Then offer for recycling if available or reconditioning if appropriate, or puncture and dispose of in a sanitary landfill, or by incineration.
