PRINCIPAL INGREDIENTS: Proprietary food grade ingredients, isopropyl alcohol, phosphoric acid, and secondary alcohol ethoxylate.

DIRECTIONS FOR USE

In non-chlorinated water

1. Mix 1 gallon (3.8 liters) of 180 Cleaner in 50 gallons (190 liters) of water.
2. Solution should be at a pH of 3.0-4.0.
3. Apply by either overhead spray above brush bed or in soak tank.
4. Rinse thoroughly with potable water.

In chlorinated water

1. Mix sodium hypochlorite and water to achieve recommended parts per million of chlorine (50-200 ppm).
2. Add 180 Cleaner to chlorinated water to achieve a pH of 6.5-7.0.
3. Apply by either overhead spray above brush bed or in soak tank.
4. Rinse thoroughly with potable water.

HANDLING: Causes severe skin burns and severe eye damage. Wear safety goggles or face shield, impermeable clothing, and chemical resistant gloves when handling. Do not get in eyes or on skin. Wash hands thoroughly after handling. May cause respiratory irritation. Avoid breathing mist/vapor/ or spray and only use outdoors or in a well-ventilated area.
