DIRECTIONS FOR USE

- 1. Prepare use-solution of 1 part $\bf Acidex\ Duo\ to\ 20$ 40 parts water, depending on desired strength.
- 2. Apply to fruit with overhead spray on brush bed.
- 3. Dwell time of 30-60 seconds is desirable for best results.
- 4. Thoroughly rinse with potable water.

STORAGE AND DISPOSAL

STORAGE: Store in locked location. Store in cool, dry, well-ventilated area. Store in corrosive resistant container with a resistant inner liner. Store away from incompatible materials such as bases, reducing agents, oxidizers, and metals. Keep container upright to prevent leakage and avoid release into environment. Absorb any spillage to prevent material damage.
