1. Use 1 part Field Clean to 20 parts water.
2. Apply use-solution to fruit in flume system or by spraying onto fruit as it enters a brush bed.
3. If spraying, brush fruit to loosen soil and spray deposits for 30 - 60 seconds.
4. Fruit must be rinsed with potable water following application.

STORAGE AND DISPOSAL

STORAGE: Store in locked location. Store in cool, dry, well-ventilated area. Store in corrosive resistant container with a resistant inner liner. Store away from incompatible materials such as acids, oxidizing agents, metals, and maleic anhydride. Keep container upright to prevent leakage and avoid release into environment. Absorb any spillage to prevent material damage.

PRODUCT DISPOSAL: Wastes resulting from the use of this product must be disposed on site or in accordance with local/regional/national/ or international regulations.

CONTAINER DISPOSAL: Nonrefillable container. Do not reuse or refill empty container. Triple rinse (or equivalent) during mixing and loading.
