- 2. Expose fruit in treatment water for 1-2 minutes.
- 3. Rinse thoroughly with potable water.
- 4. For optimum results, maintain use-solution at approximately pH 2-3.
- 5. To ensure dispersion of Mineral-XX in dump tank water, regularly agitate solution

NOTE: Chlorine reacts violently in the presence of acids. DO NOT add chlorine to submersion tanks containing Mineral-XX.

STORAGE AND DISPOSAL

STORAGE: Store in a cool, dry, well-ventilated area. May be corrosive to metals: Keep in original container. Store in corrosive resistant container with a resistant inner lining. Keep container upright to prevent leakage. Do not contaminate water, food or feed by storage or disposal. Absorb spillage to prevent material damage and store in a locked location. Keep out of reach of children.
