## WARNING

#### HAZARD STATEMENTS

Causes skin irritation. Causes serious eye irritation. May cause an allergic skin reaction.

#### PRECAUTIONARY STATEMENTS

Avoid breathing mist, vapors, or spray. Wash hands thoroughly after handling. Contaminated work clothing should not be allowed out of the workplace. Wear protective gloves, clothing and eye protection.

#### FIRST AID STATEMENTS

**IF ON SKIN:** Wash with plenty of soap and water. If skin irritation or rash occurs: Get medical advice/attention. Take off contaminated clothing and wash it before reuse.

### DIRECTIONS FOR USE

1. Apply Natural Shine® 505-OR full strength over brushes to clean, dry fruit.

2. Use 1 gallon (3.8 liters) Natural Shine® 505-OR per 8,000 - 12,000 lbs (3600 - 5400 kg) of fruit.

3. Apply using overhead spray or drip system over brushes having at least 50% horsehair to help spread the wax. Brush speed should not exceed 100 rpm.

4. White spots may develop in this coating from condensation when fruit is removed from cold storage.

**NOTICE:** Food & Drug Administration Act 403(i)(2) requires that fresh produce coated with this product be labeled "Coated with food grade vegetable and/or shellac based resin or wax" on bulk and individual retail/consumer packages.

#### STORAGE AND DISPOSAL

**STORAGE:** Store in a cool, dry area at room temperature and away from direct sun-light. Store away from incompatible materials (see Section 10 of the SDS). Keep container tightly closed and upright to prevent leakage and contamination. To prevent contamination, maintain pump suction tube in a sanitary condition if it will be inserted into product container when not in use. Keep out of reach of children and livestock.

**PRODUCT DISPOSAL:** Wastes resulting from the use of this product must be disposed on site or in accordance with local/regional/national/ or international regulations.

**CONTAINER DISPOSAL:** Nonrefillable container. Do not reuse or refill empty container. Triple rinse (or equivalent) during mixing and loading. Recycling decontaminated containers is the best option of container disposal. Decontaminated and punctured containers may also be disposed of in a sanitary land fill.
