DIRECTIONS FOR USE

PacRite 505-35 is designed to provide shrinkage control of citrus fruit during prolonged storage. This product must be diluted prior to use and applied as a spray over moving brushes. The dilution ratio varies with fruit quality and duration of storage period. Consult your PACE technical representative for proper dilution for application being used or usage on additional commodities. Use entire contents within 120 days after opening.

NOTICE: Food & Drug Administration Act 403(i)(2) requires that fresh produce coated with this product be labeled "Coated with food grade vegetable and/or shellac based resin or wax" on bulk and individual retail/consumer packages.

HANDLING: Causes eye irritation and mild skin irritation. Wear safety glasses, protective clothing, and chemical resistant gloves when handling. Do not get in eyes or on skin. Wash hands thoroughly after handling.

STORAGE AND DISPOSAL: Store container in a dry and cool area. Store out of direct sunlight. STORAGE TEMPERATURE: 41°F (5°C) to 95°F (35°C). Do not allow to freeze. Keep container closed and upright to prevent leakage and contamination. This product is harmful to aquatic life with long lasting effects: avoid release into the environment.
