DIRECTIONS FOR USE

- 1. For maximum effectiveness, add Foam-Cide to solution before foam builds up.
- 2. Add Foam-Cide at rate of 1 to 2 oz. (30-60 ml) per 1000 gal. (3800 L) solution, initially.
- 3. Increase or reduce rate in subsequent solutions as conditions warrant.
- 4. Maximum rate: 16 oz. (475 ml) Foam-Cide per 1000 gal. (3800 L) solution.

HANDLING: Causes eye irritation and mild skin irritation. Wear safety glasses, impermeable clothing, and chemical resistant gloves when handling. Do not get in eyes or on skin. Wash hands thoroughly after handling.
