PRINCIPAL INGREDIENTS: Dodecylbenzene sulfonic acid, sodium metasilicate, sodium tripolyphosphate and other proprietary ingredients.

DIRECTIONS FOR USE

1. Dilute 1 gallon (3.8 liters) PacFoam Plus to 19 gallons (72 liters) of water.
2. Wash over firm brushes at 120 - 130 rpm for 30 seconds.
3. Rinse with potable water.
4. Dilution rate may be varied with the amount of build-up on the fruit.
5. Maintain a steady and even flow of detergent on fruit.

HANDLING: Causes severe skin burns and serious eye damage. Wear safety goggles or face shield, impermeable clothing, and chemical resistant gloves when handling. Do not get in eyes or on skin. Wash hands thoroughly after handling. Avoid breathing mist/vapor/ or spray and only use outdoors or in a well-ventilated area.
