DIRECTIONS FOR USE

- 1. For use on stone fruit and other soft fruits and vegetables.
- 2. Apply at full strength on clean, dry fruit at a rate of 1 gallon per 75,000 pounds of fruit.
- 3. For best results, apply at 100°F as a drip or spray.
- 4. May be applied in conjunction with approved post-harvest fungicides.

NOTICE: Food & Drug Administration Act 403(i)(2) requires that fresh produce coated with this product be labeled "Coated with food grade petroleum-based wax or resin" on bulk and individual retail/consumer packages.


