DIRECTIONS FOR USE

Add PacRite pH Increaser to process water at room temperature, either manually or dispensed through automatic feed and control systems. Add product to water slowly to avoid violent spattering.

HANDLING: Corrosive, harmful if swallowed. Can cause severe eye and skin burns. Wear impermeable clothing, goggles or face shield, and protective gloves when handling.
