Protective Emulsion Coating for Stone Fruit and Vegetables

Prima Fresh 220 is a mineral oil emulsion formulated to coat stone fruit and vegetables, provide shine and minimize dehydration and/or loss of firmness. Prima Fresh 220 may be used as a vehicle for applying post-harvest fungicides. Read the fungicide label for specific directions.

PRINCIPAL INGREDIENTS: White mineral oil and proprietary food grade ingredients.

DIRECTIONS FOR USE

- 1. Prima Fresh 220 may be applied directly to clean and dried fruit, or it may be diluted with soft water before application.
- 2. One gallon (3.8 liters) of concentrated Prima Fresh 220 will treat 20,000 25,000 pounds (9100 11,300 kg) of fruit.
- 3. If mixing with post harvest fungicides, agitate continuously. May be injected into aqueous fungicide mixture.

NOTICE: Food & Drug Administration Act 403(i)(2) requires that fresh produce coated with this product be labeled "Coated with food grade petroleum-based wax or resin" on bulk and individual retail/consumer packages.

HANDLING: Causes skin irritation. May be harmful in contact with skin. Causes serious eye irritation. May cause respiratory irritation.
