A liquid post-harvest treatment to protect and extend the storage and shelf life of fruit.

Contains 500g Semperfresh a.i.

**Ingredients:** Sucrose Esters of Fatty Acids, E 473. Sodium carboxymethylcellulose, E 466. Mono-diglycerides of Fatty Acids, E471.

#### Precautions

Keep liquid SEMPERFRESH unopened and in its original pack at all times prior to use.

Unopened product may be held for up to two years. Do not use after expiry date indicated below.

Liquid SEMPERFRESH is stable within a pH range of 6.0 to 8.5. It is compatible with most post-harvest fungicides and chemicals such as anti-oxidants. Liquid Semperfresh is incompatible with sodium orthophenylphenate and calcium ions.

In situations where there is a risk of superficial scald developing, anti-scald treatment such as DPA or ethoxyquin must be used.

At temperatures below 15°C (60°F), liquid SEMPERFRESH will become viscous and difficult to mix. This is reversed on warming to temperatures above 15°C (60°F).

Liquid SEMPERFRESH is harmless, non-corrosive and non-toxic. However, it is recommended that the product be kept out of reach of children and that hands and exposed skin are washed before meals and after work.

#### Instructions for use

Shake well before use. To aid mixing, store the unopened container at 15-30°C prior to use (60-85°F). Pour entire contents of container slowly in the water flow as the treatment tank is filled. Leave diluted product for 30 minutes, stirring occasionally. If fungicides are used, add them to the diluted product. Treat fruit by any method which ensures total coverage, i.e. dip, drench or spray methods. Diluted product may be used for up to 5 days.

**IMPORTANT:** Read the information below before using this product. If the terms are not acceptable, you should return the unopened product container immediately for a complete refund.
