#### DIRECTIONS FOR USE

##### Fruit Cleaning:

1. Dilute Shield-Brite® Vacate 1:32 with water (4 oz. Shield-Brite Vacate per gallon of water).
2. Apply by spray over brushes.
3. Rinse.

##### General Cleaning:

1. Dilute Shield-Brite Vacate with water. Dilution can range from 1:5 to 1:32, depending on desired strength of cleaning solution. Consult your PACE representative for best results.

2. Apply with pressure spray.
3. Rinse.

#### STORAGE AND DISPOSAL

**STORAGE:** Store in locked location. Store in a cool, dry, well-ventilated area away from direct sunlight. Store in corrosive resistant container with a resistant inner liner. Store away from incompatible materials such as bases, reducing agents, oxidizers, and metals. Keep container upright to prevent leakage and avoid release into environment. Harmful to aquatic life. Absorb any spillage to prevent material damage.
