- 1. Dilute one (1) gallon Sooty Mold Cleaner to nineteen (19) gallons of water.
- 2. Wash over firm brushes at 120 130 rpm for 30 seconds.
- 3. Rinse with potable water.
- Dilution rate may be varied with the amount of build-up on the fruit.
- Maintain a steady and even flow of detergent on fruit.
