DIRECTIONS FOR USE

1. For maximum effectiveness, add Foam-Cide to solution before foam builds up.
2. Add Foam-Cide at rate of 1 to 2 oz. (30-60 ml) per 1000 gal. (3800 L) solution, initially.
3. Increase or reduce rate in subsequent solutions as conditions warrant.
4. Maximum rate: 16 oz. (475 ml) Foam-Cide per 1000 gal. (3800 L) solution.
