For Agricultural Use Only

This product conforms with FDA regulations, 21 CFR, Part 172, for food coatings.

PRINCIPAL INGREDIENTS: Isopropyl alcohol and proprietary food grade ingredients. Contains a rosin ester identified as a potential skin sensitizer. Could cause an allergic reaction.

DIRECTIONS FOR USE

1. Apply at full strength to clean dry apples.
2. Optimum results may be achieved by application at a rate of 1 gallon (3.8 liters) of product per 9000 - 11,000 pounds (4100 - 5000 kg) of fruit.
3. Adjust application rate to achieve uniform and complete coverage of fruit with coating, based on application equipment and fruit condition.
4. Dry fruit thoroughly before packing.
5. Completely flush application system with fresh, warm water at the end of each day's operation.
6. White spots may develop in this coating from condensation when apples are removed from cold storage.
7. It is recommended to use the entire contents of an opened container within 2 weeks.

NOTICE: Food & Drug Administration Act 403(i)(2) requires that fresh produce coated with this product be labeled "Coated with food grade vegetable and/or shellac based resin or wax" on bulk and individual retail/consumer packages.

HANDLING: Causes mild skin irritation and serious eye irritation. May cause an allergic skin reaction. Wear safety glasses, impermeable clothing, and chemical resistant gloves when handling. Do not get in eyes or on skin. Wash hands thoroughly after handling. May cause dizziness, drowsiness or respiratory irritation.
