PRINCIPAL INGREDIENTS: Sodium metasilicate, sodium hydroxide, petroleum distillates, 2-Butoxyethanol, nonylphenyl polyethylene glycol ether, potassium hydroxide and proprietary ingredients.

DIRECTIONS FOR USE

1. Wax Strip Plus may be used at full strength or diluted to no less of a concentration than 1 part Wax Strip Plus with 10 parts water.
2. Dilute Wax Strip Plus to desired strength.
3. Apply prepared solution by spraying on surface to be cleaned including brushes, belts, rollers and sizing cups.
4. Allow to soak for 10 - 15 minutes.
5. Flush with warm water.
6. Use Wax Strip Plus weekly to assure packing line is kept clean. Clean application and handling equipment will result in optimum fruit quality.
