**PRINCIPAL INGREDIENTS:** Sodium hydroxide and proprietary ingredients.

### DIRECTIONS FOR USE

For typical field soil and natural wax removal, use 1 ounce of Real Clean per gallon of cold or warm water. When feeding Real Clean with a proportioning system or pump, adjust so that a slight foam cap is present in tanks or vats. Thoroughly rinse with potable water.

**HANDLING:** Causes severe skin burns and severe eye damage. Wear safety goggles or face shield, impermeable clothing, and chemical resistant gloves when handling. Do not get in eyes or on skin. Wash hands thoroughly after handling. May be harmful if swallowed. Avoid breathing mist/vapor/ or spray. If vapors are present at or above TLV, respiratory protection must be worn.
