## Hard Water “Bloom” Remover for Apples

### For Agricultural Use Only

**PRINCIPAL INGREDIENTS:** Dodecylbenzene sulfonic acid, phosphoric acid, sodium dodecylbenzenesulfonate and proprietary ingredients.

### DIRECTIONS FOR USE

1. Prepare use-solution of 1 part **Acidex** to 20 - 40 parts water, depending on desired strength.
2. Apply to fruit with overhead spray on brush bed.
3. Dwell time of 30-60 seconds is desirable for best results.
4. Thoroughly rinse with potable water.

**HANDLING:** Causes severe skin burns and severe eye damage. Wear safety goggles or face shield, impermeable clothing, and chemical resistant gloves when handling. Do not get in eyes or on skin.
