PRECAUTIONARY STATEMENTS

FIRST AID STATEMENTS

IF ON SKIN: Wash skin with plenty of soap and water. If skin irritation or rash occurs: Get medical advice/attention.

IF IN EYES: Hold eye open and rinse slowly and gently with water for 15 – 20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Get medical advice/attention if irritation persists.

DIRECTIONS FOR USE

- 1. Apply full strength to clean fruit over brushes at a rate of 8,000 to
- 12,000 pounds (3600 5400 kg) of fruit per 1 gallon (3.8 liters).
- 2. Apply with a spray or drip system.
- 3. When applying this product, use the least amount of antifoam needed to control foam.
- 4. Clean application equipment every eight hours with warm, fresh water.
- 5. Use a wax stripper weekly or as needed.
- 6. For more recommendations or instructions specific to your situation, consult your Pace Technical Representative.

STORAGE AND DISPOSAL

STORAGE: Store container in a dry and cool area. Do not allow this product to freeze. Store indoors at temperatures between 40° - 90°F. Keep container closed and upright to prevent leakage and contamination. Once opened, use entire contents within 45 days. Store away from incompatible materials.

PRODUCT DISPOSAL: Wastes resulting from the use of this product must be disposed on site or in accordance with local/regional/national/ or international regulations.

CONTAINER DISPOSAL: Nonrefillable container. Do not reuse or refill empty container. Triple rinse (or equivalent) during mixing and loading. Recycling decontaminated containers is the best option of container disposal. Decontaminated and punctured containers may also be disposed of in a sanitary land fill.
